<p style="text-align: center;">INSTRUCTIONS TO VOTER</p> <p>The following are instructions on how to vote your ballot. Please follow these instructions precisely, otherwise, your ballot may not be counted.</p> <ol style="list-style-type: none"> 1. Verify that there are initials of an election official at the bottom of the ballot. 2. Verify that there are no voting marks on the ballot. 3. Use a black pen to mark the ballot. 4. TO VOTE, you must darken the oval (●) completely. Circling or placing other marks outside of the oval will not suffice. 5. Do NOT cross out or erase. If you make a mistake, contact the County Clerk's office at 402-755-5602 for instructions. 6. Place voted ballot into the return envelope and complete, SIGN and seal envelope. 7. Any person physically unable to sign the envelope must make his/her "mark" and must have an individual witness. Failure to complete and sign the Return Identification Envelope will cause the ballot to be rejected. 8. Do NOT place more than ONE (1) voted ballot into the return identification envelope. 9. Return Ballot by: <ol style="list-style-type: none"> a. Hand Delivery - deliver the ballot to the office of the County Clerk/Election Commissioner. b. Mail - return ballot by mail by placing proper return postage on the envelope. c. Drop Box Location available at the front of the Courthouse at 302 W. 3rd St, Ponca, NE. 10. Ballot MUST be in the possession of the County Clerk's office by 5:00 p.m. November 14, 2023. 	<p>School Bond Election Wayne County School District 0560 (Wakefield Community Schools) In the State of Nebraska</p> <p>"Shall Wayne County School District 0560 (Wakefield Community Schools) in the State of Nebraska issue its general obligation bonds in an aggregate stated principal amount not to exceed Forty-Six Million Eight Hundred Thousand Dollars (\$46,800,000), to pay the costs of constructing additions, renovations and improvements to the District's existing school buildings and facilities, and providing necessary equipment and apparatus for such buildings and facilities; with such bonds to be issued in one or more series, at such time or times, to bear interest at such rate or rates, to be sold at such prices and to become due at such time or times as may be fixed by, or determined at the direction of, the Board of Education; and</p> <p>"Shall the School District cause to be levied and collected annually a special levy of taxes against all the taxable property in the School District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?"</p> <p style="text-align: center;"> <input type="radio"/> FOR such Bonds and tax <input type="radio"/> AGAINST such Bonds and tax </p> <p>Electors voting in favor of the proposition shall blacken the oval opposite the words "FOR such Bonds and tax" following such proposition, and electors voting against such propositions shall blacken the oval opposite the words "AGAINST such Bonds and tax" following the proposition.</p>
