The Dixon County Board of Supervisors met on June 18, 2024, at 9:00 A.M. for an emergency meeting at the Annex Building in Ponca, Nebraska, pursuant to the call by Lisa Lunz, Chair of the Dixon County Board of Supervisors, for an emergency meeting.
