The first regular meeting of the Dixon County Board of Supervisors for the year 2025 was convened at 9:00 A.M. for reorganization at the Dixon County Annex at 59140 Hwy 12 in Ponca, Nebraska on January 14, 2025. The meeting was opened with the Pledge of Allegiance. Notice was given to the public of the location of the posted Open Meetings Law. The following constitutes the Dixon County Board of Supervisors for 2025: Don Andersen District #1, Deric Anderson District #2, Roger Peterson District #3,

Neil Blohm District #4, Lisa Lunz District #5, Terry Nicholson District #6, Steven Hassler District #7.
