

DIXON COUNTY BOARD OF SUPERVISORS PROCEEDINGS

The Dixon County Board of Supervisors met on September 24, 2024, at 9:00 A.M. for an adjourned Special meeting at the Dixon County Annex Building in Ponca, Nebraska. Chair Lisa Lunz opened the meeting with the Pledge of Allegiance and called for roll call of members present. Answering was: Don Andersen, Neil Blohm, Terry Nicholson, Steve Hassler, Roger Peterson, Deric Anderson and Lisa Lunz. Absent: None. Also present were Cathy Stilwell, Dixon County Clerk and Secretary to the Board of Supervisors and other interested persons. Chair Lunz gave notice to the public of the location of the posted Open Meetings Law. Motion was made by Nicholson, seconded by Andersen to show that this meeting was preceded by due and legal notice by posting as required by law in the Bank of Dixon County, bulletin board in the lower hall of the courthouse, bulletin board in the County Clerk's office and two County newspapers, and all Board Members were notified simultaneously and the agenda of all known business to come before the Board of Supervisors was posted in the office of the County Clerk. On roll call vote, Motion carried. Supervisors voting in favor of said motion were: Don Andersen, Neil Blohm, Steve Hassler, Terry Nicholson, Roger Peterson, Deric Anderson, and Lisa Lunz. Absent: None. Supervisors voting against: None.

At 9:00 A.M. the Final Tax Request Hearing was held. Chair person Lunz stated the budget numbers of the Amount of the Property Tax Request is \$5,573,787.24. The total assessed value of property differs from last year's total assessed value by 17.11% The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be .227559 per \$100 of assessed value. The Dixon County Board of Supervisors had proposed to adopt a property tax request that will cause its tax rate to be .241748, based on the proposed property tax request and changes in other revenue, the total operating budget of the Dixon County Board of Supervisors will increase compared to last year's operating budget by 3.45%. After discussion and no comments by persons attending the hearing concluded at 9:13 A.M.

At 9:15 the Budget Hearing was held. Chair Lunz stated the tax request is \$5,573,787.24. After discussion and no other comments, the hearing concluded at 9:19 A.M.

After the hearing concluded, the Board of Supervisors commenced into the Special meeting as advertised, September 17th, 2025.

Motion by Nicholson to adopt the resolution for the 2025-2026 budget, seconded by Peterson. On roll call vote, Motion carried. Supervisors voting in favor of said motion were: Don Andersen, Neil Blohm, Steve Hassler, Terry Nicholson, Roger Peterson, Deric Anderson, and Lisa Lunz. Absent: None. Supervisors voting against: None. **Resolution in Resolution & Ordinances Book 3, Page 593.**

Motion was made by Hassler adopt the resolution setting a tax request at a different rate than last year. Seconded by Anderson. On roll call vote: Motion carried. Supervisors voting in favor of said motion were: Don Andersen, Neil Blohm, Steve Hassler, Terry Nicholson, Roger Peterson, Deric Anderson, and Lisa Lunz. Absent: None. Supervisors voting against: None. **Resolution in Resolution & Ordinances Book 3, Page 594.**
